# **Umina Surf Life Saving Club Inc.**

# Lease of Sponsored Fibreglass Board Agreement for Competitors

### **Rules Governing Sponsorship**

The following rules govern Club sponsorship and all conditions must be fulfilled 100% before the Club will make any commitment. This is a three year contract and the board will be returned to Umina SLSC at the end of the contract.

It must also be understood that the Club Executive has the final say in all cases and at any time the Executive thereof can dismiss the sponsorship scheme in its entirety or part.

This form accompanied by a letter outlining the Member's claim should be returned to the Board Captain by the end of 31 May 2017.

#### **RULES**

- 1. The Club, the Sponsor and the Member each agree to pay 1/3 of the value of the board, the artwork, the logo and a board bag.
- The Member's share must be paid in advance prior to an order being placed and the Club providing any funds. All monies are to be paid to the Umina SLSC Treasurer or the Assistant Treasurer.
- A letter addressed to the Executive should accompany this application, outlining the Member's claim for sponsorship and must be signed by the Member and a legal guardian, if applicable. The letter should state the Member's competition history.
- 4. An application alone will not constitute acceptance. Initially, all applications must be endorsed by a Board Coach and the Board Captain, with final approval being granted by the Club Executive.
- 5. If a Member feels, his/her application has been unfavourably endorsed by the Coach, the Member may then make representations directly to the Club Executive, stating their reasons. The decision of the Club Executive will be final.
- 6. The Member must be a genuine competitor and have had the previous season competition to their credit at their respective level of competition.
- 7. Maximum of one purchase of craft is allowed in the contract period by the user.
- 8. The craft remains the property of Umina Surf Life Saving Club Inc at all times, and is not the property of the Member. The Club Executive may at their discretion, allow the Member the option of purchasing the Club's and the Sponsor's share of the craft at an agreed valuation established by the Executive Committee at the time.

- 9. The Member is responsible for the upkeep and maintenance of the craft, any damage must be reported to the Umina SLSC Board Captain and repairs must be carried out by a professional repairer. An inspection of the craft will be performed at the beginning and at the end of the season by the Board Captain. If the craft is in disrepair, the Member may forfeit his/her rights under this contract and be required to return the craft to the Club.
- 10. If the craft lays unused for a period of 12 months without reasonable explanation, the Member may forfeit his/her rights under this contract and be required to return the craft.
- 11. The sponsored craft is to be used solely by the Member having the sponsorship.
- 12. The Member is responsible for requesting an invoice and presenting it to the Board Captain for the full cost of the board, artwork, Logo and board bag. 1/3 of the cost of the board (refer to clause 1) must be paid to the Club by the Member before the board is ordered. Payment will be made directly to the manufacturer by the Treasure of Umina Surf Lifesaving Club.
- 13. Umina Surf Life Saving Club Inc has, at all times, the right to dispose of the craft for any reason and at such valuation as per clause 8.
- 14. Failure to comply with any of these rules, or mistreatment of the equipment (sponsored or Club owned), or breaking of any general Club rules etc. will result in the automatic forfeiture of any rights otherwise granted by this contract to the said sponsored craft, requiring it's immediate return to the Club.
- 15. The board should be transported at all times in the bag provided.
- 16. If it is a Mal that is sponsored, the Member must complete the appropriate patrol hours that are necessary to be able to compete in any season that the sponsorship covers. If they fail to do this they can forfeit their rights of sponsorship and the board will be returned to the Club.
- 17. A covering letter and completed application are to be presented to the Board Captain and the Board Captain will then present the applications, in order of priority, to the Executive for their approval.
- 18. It should be noted that Executive approval for board sponsorship applications are subject to availability of sponsors and funds.
